



# Camping ban update

There have been a few more developments regarding the Fremont Homeless Response, otherwise known as the camping ban. First, Council on March 4<sup>th</sup> voted to request that the City Manager remove the "aiding and abetting" language and the ban of camping on private property for more than 72 hours from the ordinance. The vote was 6-1 in favor. Councilmember Campbell proposed to reduce the penalty for infractions of any portion of the ordinance from a misdemeanor to a civil infraction. That proposal was rejected (no one else seconded the motion) and she voted against the passing proposal in protest. It is worth noting that the Mayor asked for a poll of who wanted to change the penalty from a

misdemeanor and Councilmembers Campbell, Keng and Kimberlin voted to do that and the others (Shao, Lu, Zhang, Salwan) said they wanted to maintain the criminalization provision of the ordinance. The justification mayor Salwan gave for maintaining the criminalization is to provide the police with more "tools" to achieve compliance with not camping. The revised camping ban ordinance is expected to come back to Council March 18<sup>th</sup>.

The next update is that an outside group, The California Homeless Union, filed a lawsuit in Federal Court seeking to nullify the ban on grounds that it will create "what will otherwise be a completely preventable humanitarian crisis in the city of Fremont." A key part of the lawsuit is that disabled people will be impacted by being forced to vacate their shelter when they have no place to go. The judge asked the City to place a hold on enacting the ban pending the outcome of the revised camping ban and also deferred considering the lawsuit until the revised ban is enacted. Stay tuned, I can guarantee there will be more updates in subsequent months.

What does the camping ban mean? A nice article by Calmatters, <a href="https://calmatters.org/housing/homelessness/2025/02/california-homeless-encampment-sweeps/">https://calmatters.org/housing/homelessness/2025/02/california-homeless-encampment-sweeps/</a> says that the effect of camping bans is that unhoused people simply pack up their belongings and move around during the day so they are not "camping" for more than 24 hours. As many have said, the number of unhoused has not changed because of camping bans. However, the ability to provide assistance has become much harder since case workers now have a hard time keeping in touch the clients and other groups (many faith based) providing basic provisions like food and clothing.

A question should be asked if the Fremont community can ever come together. There are very clear coalitions for and against the camping ban. Times will get harder in Fremont. Tax revenue is already down. School attendance is down and that will result in disruption from teacher layoffs and school closures. A divided community that can't come together on the unhoused will be challenged to come together to solve other problems.

# **Ridwell-Leading Edge Recycling:**

We have been members of Ridwell for about a month and so far we are liking it. Ridwell is a subscription recycling service that aims to make recycling more convenient and accessible for households. They pick up items that are not typically accepted in curbside recycling, such as multi-layer plastic, plastic film, batteries, rewearable clothes and recyclable thread.

Ridwell provides an app for scheduling pickups and a metal bin and reusable labeled canvas bags. For an extra charge we can add styrofoam to a pickup. The styrofoam is placed in a larger bag and placed next to our bin.

We have found it to be a convenient way to keep items out of the landfill. We have diverted 14 pounds from the landfill after only 2 pickups.

We like Ridwell's transparency and auditing of where the recycling goes. They publish where it all goes here <a href="https://www.ridwell.com/transparency">https://www.ridwell.com/transparency</a>

In the Bay Area Ridwell has diverted ~ 1.7 million pounds of waste from landfill. Here is a further breakdown for the Bay Area:

- Plastic Film 92.5% diverted. Trex turns the plastic film into new decking material.
- **Multi-Layer Plastic** 93.05% diverted. Merlin, First Star, Hydroblox and ByFusion recycle multi-layer plastic into building and drainage materials.
- **Styrofoam: 71.9**% diverted. National Recycling Corporation changes it into things like picture frames.
- Batteries: 100% diverted. Cal2Recycle recovers material to create new batteries.
- **Threads:** 100% diverted. Goodwill of San Francisco Bay recycles or reuses everything.

• Light Bulbs: 100% diverted. Clean Earth recycles these.

It's really nice to have an option to recycle multi layer plastic! We have not been able to recycle this in the past. We can drop off plastic film at our local Safeway, but we find it convenient to have this picked up by Ridwell along with our other items.

We have also helped our neighbors recycle light bulbs and it was rewarding to help our local community recycle.



Every two weeks, they also have a special featured category. For the last pick up our featured category was #5 plastic prescription bottles. Our upcoming featured categories are silverware and kitchen utensils, books, rigid plastic rings and non-perishable food. We like that we receive texts and emails to remind us to opt into a pickup. It does take some time to separate the items into bags (see photo) and to follow the Ridwell instructions.

If it fits into your budget and you are keen on diverting items from the landfill, Ridwell might be a good fit.

This means that the monthly fee paid to Ridwell provides a means to recycle items that otherwise won't be recycled. Multi-layer plastic is likely one of the items Ridwell pays someone to reuse since no one else takes it. Note that the Ridwell processing center in the Bay Area is in San Leandro. TCEC will see if a tour can be arranged.

#### **TCEC Election Results**

Thanks to all the voting members who have returned their ballots. I am pleased to announce all four officers have been returned to office.

Chair - Caroline Harris Vice Chair - Liz Ames Treasurer - Beth Rasler Secretary - Janis Stob

And the motion set to the members to amend the bylaws was approved by 96% of the votes, resounding support from the membership, thank you all very much. The 2025 bylaws will be posted on our website. As a reminder the big change was to move the officers election to every two years instead of annually, other changes were to bring the bylaws in line with current practices, like meeting on Zoom and renaming the Communication Committee to Technical and Media Committee to cover electronic communication and bill payments. We also changed the requirement of having two signatures on checks only if the amount exceeds \$500. We added a section for Affiliate Partners to cover our Urban Forest Friends (UFF), Washington High School Ecology Club and California Orchard Restoration Experiment (CORE).

# Take advantage of the Inflation Reduction Act Now

Act before it's too late. It may already be too late. The rebate portion of the Inflation Reduction Act available to low-income residents is on hold due to executive actions from

the new regime. Check <a href="https://techcleanca.com/incentives/heehrarebates/">https://techcleanca.com/incentives/heehrarebates/</a> for any updates.

Tax rebates are different since they are administered through your taxes and only Congress can remove them. Latest news is that Congress won't pass a reconciliation bill until later in the year, so you may have time. So take advantage of the Inflation Reduction tax credit while you still can. Install a heat pump water heater if your water heater is more than 10 years old. Go the <a href="https://www.switchison.org/ca">https://www.switchison.org/ca</a> or <a href="https://incentives.avaenergy.org">https://incentives.avaenergy.org</a> to look for credits and other rebates that can be used to reduce fossil fuel consumption.
